TERMS OF PAYMENT

Prepaid orders accepted by Visa, Master Card, American Express, Business Cheque, or Money Order. For credit card orders, please provide us with credit card number, expiry date, and name of cardholder. Credit Card Authorization forms must be updated on a yearly basis. Credit application will be accepted from established accounts after being active for 12 months. Credit Limits and terms apply and will be revised annually or reviewed at customer's request. Accounts exceeding the agreed upon terms of payment and/or credit limit will be placed on a NO SHIP status until account is cleared up. A service charge of 2% per month will be applied to all overdue accounts. N.S.F. cheques and overdue accounts will automatically convert to a Credit Card status. A service charge of \$50.00 will apply to all N.S.F. cheques. Accounts overdue for 60 days will be sent for collection. All administrative and collection costs are applied to the outstanding balance. Account Holder is responsible for all purchases made by additional buyers listed on the account.

MAIL & TELEPHONE ORDERS

Are accepted by phone, fax, e-mail, and regular mail, or shop in person in our Toronto Showroom. Prices are net F.O.B. Toronto. First order minimum is \$500.00. Subsequent orders are \$300.00 minimum. A minimum yearly amount of \$2000.00 must be maintained to keep your account active. International orders must be a minimum of \$500.00 in merchandise. Shipping charges are extra. We reserve the right to correct any pricing and/or shipping errors. For any orders shipped the minimum shipping charge is \$10.00, within Canada and \$15.00 in the U.S.A.

TORONTO SHOWROOM PARCEL PICKUP

All orders require a 24hr-processing period for pick-up after 2:00 the next business day. Method of payment can be Cash, Debit Card, Visa, Master Card, American Express Money Order, or Business Cheque, once Credit Application has been approved.

TORONTO SHOWROOM ORDERS

First order minimum is \$500.00. Subsequent orders are \$300.00 minimum. No order will be processed under \$300. For insurance and safety regulations please note that children under the age of 18 are not allowed in our Showroom. Also, no pets are allowed.

RETURNS

If your order was placed through the Order Desk you must first call for an RMA (Return Merchandise Authorization) to ship back and you must return items via our Courier.

No credit for damaged or wrong merchandise shipped – items will be replaced, credit only if not in stock.

No returns or credit for special orders, clearance merchandise, special sale items, cut items, or wearable items.

Returns for any reason except our error will be subject to a 20% restocking charge. All merchandise must be returned in original packaging with a copy of the original invoice.

Showroom Shopping – All Sales are Final- No Returns will be accepted

We reserve the right to adjust prices when necessary without notice. Prices will vary due to market conditions, order quantities, product availability and currency fluctuation.

SPECIAL ORDERS

All special orders must have a deposit of 30% of total value, which is non refundable. No cancellations or returns will be accepted on special orders.

INTERNATIONAL

WE REQUIRE PROOF OF BUSINESS AS APPLIES TO THE COUNTRY IN WHICH YOU RESIDE

WHEN PURCHASING AT JOHN BEAD

AS A VISITOR TO ONTARIO YOU WILL BE CHARGED HARMONIZED SALES TAX (HST). THE HST IS COMPRISED OF:

GST - THE FEDERAL GOODS AND SERVICES TAX OF 5%. THIS IS A VALUE-ADDED CONSUMPTION TAX THAT APPLIES TO MOST GOODS, PURCHASED GIFTS, FOOD/BEVERAGES, AND SERVICES.

PST - THE ONTARIO PROVINCIAL SALES TAX OF 8% ON ANY GOODS YOU BUY.

TO RECEIVE YOUR TAX REFUND:

GST - VISITORS FROM OUTSIDE CANADA MAY CLAIM A REFUND OF THE 5% FEDERAL GST ON ACCUMULATED PURCHASES OF A MINIMUM OF \$200, PROVIDED THAT:

- EACH RECEIPT IS AT LEAST \$50 IN GOODS BEFORE TAX
- THE GOODS ARE TAKEN OUT OF CANADA WITHIN 60 DAYS OF PURCHASE
- CANADA REVENUE AGENCY REQUIRES THAT YOUR RECEIPTS BE STAMPED BY A CUSTOMS OFFICER UPON YOUR DEPARTURE FROM CANADA

FOR VISITORS WHO ARE LEAVING THE PROVINCE BY PLANE, OR FOR THOSE VISITORS NOT STOPPING AT A LAND-CROSSING DUTY FREE SHOP, FORMS MUST BE MAILED FROM OUTSIDE CANADA TO CANADA REVENUE AGENCY WITH ALL THE ORIGINAL RECEIPTS. IF YOU ARE DEPARTING FROM A MAJOR AIRPORT IN ONTARIO, YOU CAN GET YOUR RECEIPTS STAMPED AT THE CUSTOMS DESK.

IF YOU ARE DEPARTING BY CAR OR BUS, YOU CAN HAVE YOUR RECEIPTS STAMPED BY CANADA CUSTOMS AT THE BORDER.

PST - THE 8% ONTARIO PST IS ONLY REFUNDED ON PURCHASES WITH A RETAIL VALUE OF AT LEAST \$625 BEFORE TAXES. THIS MEANS THAT THE PST MUST BE AT LEAST \$50 DOLLARS ON EACH RECEIPT.

GOODS MUST BE REMOVED FROM THE PROVINCE WITHIN 30 DAYS OF PURCHASE AND REFUND APPLICATIONS MUST BE SUBMITTED WITHIN 4 YEARS.

WHEN JOHN BEAD SHIPS INTERNATIONALLY

YOU WILL NOT BE CHARGED THE HST.

PLEASE NOTE THAT THERE IS A \$500.00 MINIMUM ON ALL INTERNATIONAL ORDERS.
